**Giovanni Abramo** Giovanni Abramo is a Technology Research Director at CNR-IASI (Institute for System Analysis and Computer Science), head and founder of the Laboratory for Studies in Research Evaluation (<https://sites.google.com/view/laboratorioritt>), and president and founder of the CNR spin-off company "Research Value". He is also an Honorary Professor of Management at the University of Waikato, New Zealand, and an Adjunct Professor of Management of Innovation and Entrepreneurship at the University of Rome "Tor Vergata". He has been the acting director of CNR-IASI, and consultant to the United Nations, the European Commission, and several national and local government administrations and institutions. His research interests focus on quantitative studies of science, with a concentration in evaluative scientometrics aimed at informing research management and policy.

**Valentina Carazzolo** is a PhD student at Sapienza University of Rome in Applied Social Sciences. She obtained a master's degree in Public Policies at LUISS University of Rome. Her research interests are mainly focussed on higher education policies, on research evaluation and on researchers' research agenda setting determinants.

**Ciriaco Andrea D'Angelo** is associate professor at the Department of Engineering and Management at the *University of Rome "Tor Vergata"*, qualified for full professorship. He is member of the Steering Committee of the graduate programme in Engineering and Management and member of the PhD program committee at the *University of Rome "Tor Vergata"*. Founder of the Laboratory for Studies in Research Evaluation. Research associate at the Institute for Systems Analysis and Computer Science of CNR; visiting research fellow at the Centre for Science and Technology Studies, at Leiden University (the Netherlands). He holds research and consulting contracts from Italian public administrations, national agencies and private companies, for projects pertaining to research assessment, technology transfer, decision support system for research managers and central and local policy makers.
